

The Hebrew University Magnes Press:

– Magnes E-Books –

[...] 1.4 Institution shall not: (1) share, resell, rent, assign, timeshare, distribute, or transfer all or part of any Magnes E-Book or any rights granted hereunder to any other person; (2) duplicate any Magnes E-Book, except for a single backup or archival copy; and/or (3) remove any proprietary notices, labels, or marks from any Magnes E-Book.

Without derogating from the generality of the aforesaid, an Authorized User may not make Magnes E-Books available electronically to anyone other than another Authorized User, whether by telephone link or by permitting access through a terminal or computer or by any other means or arrangement.

1.5 For removal of doubt, it is clarified that the License does not grant any rights to make any commercial or public use of the Magnes E-Books, including without limitation any public display of the Magnes E-Books, including in the framework of any lecture, seminar, etc.

1.6 The Institution agrees and undertakes to make reasonable efforts to take appropriate action should it become aware of any misuse that would violate the terms of this Agreement and prevent same from happening. The Institution shall continue to promote an environment that does not allow for abuse of the terms of this Agreement.

3.4. Upon material breach or repeated other breaches by authorized users, Magnes may cease to authorize online access to the Magnes E-Books only by the authorized users responsible for the breach.

## Proprietary Rights

5.1 Magnes is the owner of all right, title, and interest, including copyright, translation rights, redistribution rights, and the right to produce the material in alternate media, for any and all material that can be accessed under this Agreement. Magnes E-Books and their content are subject to copyright, protections, and other rights of the publisher (Magnes) under law, contract and otherwise. The Institution acknowledges that it has no claim to ownership by reason of its use of or access through subscription to Magnes E-Books. Downloading or photocopying of the data is permitted for personal or educational use in accordance with German law.<sup>1</sup> Other recompiling, copying, publication, or republication of the data, or any portion thereof, in any form or medium whatsoever, may be done only with specific written permission from Magnes.

5.2 All intellectual property rights in the System, including without limitation copyrights, patents, trademarks, industrial designs and/or trade secrets, are owned by Magnes and are protected by applicable law and international treaty provisions. Magnes retains all rights not expressly granted herein. Party shall have no rights, claims or interest whatsoever in or with respect to the System, except for the right to use the System solely for its own internal use and its Authorized Users.
